- 1. Work Completion Time: Within 3 months after the award of the tender
- 2. Warranty Period: Two years after successful commissioning
- 3. Prequalification:

A. PRE- QUALIFICATION (PQ) CRITERIA:

(a) Technical:

Bidder must have successfully completed at least one Sewage Treatment Plant
(STP)(including Design, Engineering, Supply, Construction, Erection/Installation, Testing
&Commissioning and Trial Run) of minimum 100 KLD capacity based on 'Sequence
Batch Reactor' (SBR) Technology with Float Decanter and automatic weir gates" during
the last seven years ending on the date of scheduled bid submission (including
extension if any), which should also be in successful operation for at least one year after
commissioning.

Note:-

- i. The bidder shall submit the certificates from client for successful completion and operation of the project in support of their experience as required above indicating the details of executed work(s). The certificate should include work order no. and date, amount, date of start, actual date of completion, year of commissioning, duration of O&M with specific mention of successful O&M period of STP, etc. Bidder may also provide details of various components of STP completed by him. Bidder shall also enclose copy of work order for construction of STP and O&M Part.
- ii. For the purpose of O&M experience for a minimum period of 3 year, bidder may submit certificate for other STP, which may not have been constructed or completed by him.
- iii. For the purpose of bid evaluation, if the owner/owner's representatives feel necessary to visit a specific or all such plants as mentioned above by the bidder, the bidder shall make necessary arrangements for the same. The cost of such visits for owner's representative(s) shall be borne by the owner.
- iv. The details of the work experience may be provided as per Annexure-"M" along with the authenticated and valid supporting documents.

(b) Financial:

Bidder should have Average Annual Turnover of at least 15 crore (Rupees Fifteen Crore only) during last three financial years (ending March'2018). The Contractor shall submit the Audited Balance Sheet / Certificate of a Chartered Accountant in support of their claim.
