- 2. Eligibility Criteria for submission of bid documents:
 - (a) Experience of having successfully completed similar work individually costing not less than as stated below during the last 7 years ending previous day of last date of submission of bids.
 - (i) Three similar works, each of value not less than 40% of the estimated cost,

OR

(ii) Two similar works, each of value not less than 60% of the estimated cost,

OR

(iii) One similar works of value not less than 80% of the estimated cost,

Completion certificate issued by Competent Authority will only be considered. Competent Authority means officer of not below the Rank of Executive Engineer/ Equivalent would be acceptable.

The value of executed works shall be brought to current costing level by enhancing the actual value of work at simple rate of 7% per annum, calculated from the date of completion to last date of receipt of applications for this tender. (Copy of work completion certificate to be uploaded as proof of eligibility criteria in Cover-1)

Similar works mean: - Outsourcing/Hiring Services for Complete Horticulture Work Only. (If the awarded work is composite in nature, then only the amount of work for Horticulture is to be considered)

- 3. **Turnover:** The average annual turnover CA certificate preferably with UDIN on similar works should be at least 50% of estimated cost during the immediate last 3 consecutive Financial Year (2020-21, 2021-22 & 2022-23) balance sheet duly audited by Charted Accountant. (**Scanned copy of Certificate from CA to be uploaded**). The year in which no turnover is shown would also be considered for working out the average.
- 4. Institute reserves the right to cancel any or all tenders without assigning any reason.
- 5. Tender is invited initially for 12 months however it can be extended up to 24 months subject to the performance of the bidder or as desired by the institute. However, the service charge quoted by the bid shall be the same for the extended period. no escalation is admissible in this good. However, for the renewal of the contract bond, the bidder has to deposit all the requisite documents like security deposit, performance guarantee insurance, performance report, any other document, etc. as required by the department.
