# (a) Experience of having successfully completed similar work individually costing not less than as stated below during the last 7 years ending previous day of last date of submission of bids.

(i) Three similar works, each of value not less than 40% of the estimated cost,

OR

- (ii) Two similar works, each of value not less than 60% of the estimated cost, OR
- (iii) One similar works of value not less than 80% of the estimated cost,

The value of executed works shall be brought to current costing level by enhancing the actual value of work at simple rate of 7% per annum, calculated from the date of completion to last date of receipt of applications for this tender. (Copy of work completion certificate to be uploaded as proof of eligibility criteria in Cover-1/ Technical bid).

#### Similar works mean: - Cleaning, collection & disposal of garbage & biodegradable and nonbiodegradable waste from dustbins in segregated manner from PSUs/ Semi-Govt./ Govt. / Autonomous Institutions / Departments/ Offices.

- **4. Turnover:** The average financial annual turnover on similar works should be at least **50%** of estimated cost during the immediate last 3 consecutive Financial Year (2021-22, 2022-23, 2023-24) balance sheet duly audited by Charted Accountant. (Scanned copy of Certificate from **CA with valid UDIN** to be submitted with technical bid). The year in which no turnover is shown would also be considered for working out the average.
