- The Government of India has received/has applied for/intends to apply for financing from the World Bank toward the cost of the Renovation of First & Second Floor T.O. Wing (34 nos. of rooms) at Khosla International House, IIT Roorkee Project and intends to apply part of the proceeds toward eligible payments under the contract for construction of works as detailed below.
- 2. Bidding will be conducted through national open competitive procurement using a Request for Bids (RFB) as specified in the World Bank's "Procurement Regulations for IPF Borrowers, July 2016, Revised August 2018, November 2020" ("Procurement Regulations"), and is open to all Bidders as defined in the Procurement Regulations.
- 3. Bidders from India should be registered with the appropriate class & category of CPWD, State PWD (Buildings), MES, having experience of working in Government of India or other State Governments/ Government of India, or State/ Central Government Undertakings, Public Sector undertaking/ Autonomous Organization of the Central/State Government and Working Contractors of IITR for the work mentioned in this tender document.
- 4. On behalf of BOG, IIT Roorkee invites online Bids from eligible Bidders for the construction/ renovation of works detailed below in the table. The bidders may submit bids for any or all of the works indicated therein. Interested bidders may obtain further information and inspect the bidding document at the address given below during office hours. Bidders are advised to note

- the clauses on eligibility (Section I Clause 4) and minimum qualification criteria (Section III Evaluation and Qualification Criteria), to qualify for the award of the contract. In addition, please refer to paragraphs 3.14 and 3.15 of the "Procurement Regulations" setting forth the World Bank's policy on conflict of interest
- 5. Bids comprise two Parts, namely the Technical Part and the Financial Part, and both parts must be submitted simultaneously online as mentioned in Bid data sheet of the tender document and the 'Technical Part' of the bids will be publicly opened online on the same day as mentioned in Bid data sheet of the tender document, in the presence of the bidders designated representatives who wish to attend. The "Financial Part" shall remain unopened in the e-procurement system until the second public Bid opening for the financial part. Any bid or modifications to bid (including discount) received outside e-procurement system will not be considered. If the office happens to be closed on the date of opening of the bids as specified, the bids will be opened on the next working day at the same time and venue. The electronic bidding system would not allow any late submission of bids.
- 6. All Bids must be accompanied by a Bid Security of the amount specified for the work in the table below, drawn in favour of Instittue Engineer, IWD, IIT Roorkee. Bid security will have to be in any one of the forms as specified in the bidding document and shall have to be valid for 90 days beyond the validity of the bid. Procedure for submission of bid security is described in Para 9.
- 7. The bidders are required to upload the (a) payment documents towards the cost of bid document; and registration on e-procurement website (if applicable); (b) original bid security in approved form; and (c) original affidavit regarding correctness of information furnished with bid document on CPP Portal before the bid submission deadline, failing which the bids will be declared non-responsive and will not be opened.
- 8. A pre-bid meeting will be held as mentioned in Bid Data Sheet of the tender document at the office of Institute Engineer, IWD, IIT Roorkee to clarify the issues and to answer questions on any matter that may be raised at that stage as stated in ITB Clause 7.4 of 'Instructions to Bidders' of the bidding document, Bidders are advised to download the bidding document prior to the pre-bid meeting in order for bidders to have a good understanding of the scope of work under this contract for discussion and clarification at the pre-bid meeting.
- 9. Other details can be seen in the bidding document. The Employer shall not be held liable for any delays due to system failure beyond its control. Even though the system will attempt to notify the bidders of any bid updates, the Employer shall not be liable for any information not received by the bidder. It is the bidders' responsibility to verify the website for the latest information related to this bid.

- 8. Experience of having successfully completed similar work individually costing not less than as stated below during the last 7 years ending previous day of last date of submission of bids.
  - Three similar works, each of value not less than 40% of the estimated value,

or

• Two similar works, each of value not less than 60% of the estimated value,

or

• One similar works of value not less than 80% of the estimated value

Completion certificate issued by Competent Authority will only be considered. Competent Authority means officer of not below the Rank of Executive Engineer/ Equivalent would be acceptable.

The value of executed works shall be brought to current costing level by enhancing the actual value of work at simple rate of 7% per annum, calculated from the date of completion to last date of receipt of applications for this tender. (Copy of work completion certificate to be uploaded as proof of eligibility criteria in Cover-1).

Two contract not less than 60% value of estimate cost of E&M component in "repair and general maintenance of Electrical related work" during last seven years.

or

Three contract not less than 40% value of estimate cost of E&M component in "repair and general maintenance of Electrical related work" during last seven years.

17. Subcontractor for electrical work should have valid Electrical License of class 1 category.
