2. Eligibility Criteria for submission of bid documents:

- a. Intending bidder should not be a joint venture (Copy of relevant documents clearly establishing the status of bidder to be uploaded in Cover-1).
- b. **Experience of having successfully completed similar work individually costing not less than as stated below during the last 7 years ending previous day of last date of submission of bids.**
- (i) Three similar works, each of value not less than 40% (i.e. Rs. 3,82,56,287.00) of the estimated cost,
OR
- (ii) Two similar works, each of value not less than 60% (i.e. Rs. 5,73,84,430.00) of the estimated cost,
OR
- (iii) One similar works of value not less than 80% (i.e. Rs. 7,65,12,574.00) of the estimated cost,

Completion certificate issued by Competent Authority will only be considered. Competent Authority means officer of not below the Rank of Executive Engineer/ Equivalent would be acceptable.

The value of executed works shall be brought to current costing level by enhancing the actual value of work at simple rate of 7% per annum, calculated from the date of completion to last date of receipt of applications for this tender. (Copy of work completion certificate to be uploaded as proof of eligibility criteria in Cover-1)

- c. **Similar works mean: - New Bituminous road Construction with mechanical mean /Resurfacing & Repair of Bituminous road by Hot Mix Plant.**

3. **Turnover:** The Average Annual Turnover CA Certificate preferably with UDIN should be at least **50%** of estimated cost during the immediate last 3 consecutive Financial Years (2020-21, 2021-22, 2022-23) –balance sheet duly audited by Chartered Accountant. (Scanned copy of Certificate from CA preferably with UDIN Number to be uploaded). The year in which no turnover is shown would also be considered for working out the average.
4. The bidder should be the owner of computerized Hot Mix Plant. Proof of same has to be uploaded in technical bid. **The contractor has to establish hot Mix Plant as per tender within 30 K.M of IIT Roorkee.**
5. The Bituminous Road work shall be carried out by using bitumen of Grade VG-30 of IOCL refinery only.
6. The Tenderer have to Upload a declaration regarding capacity to deploy the following plant & Machines on his own/hire basis as per Tender. Proof of ownership or hire agreement has to be Uploaded in technical bid as follows: -

Certified copy of original solvency certificate to be uploaded in cover-1.
- 12) Proof of ownership or hire agreement for the requisite plant & machinery as mentioned in NIT.

Note 1: If any information furnished by the bidder is found as false/fabricated then his bid will be rejected and treated as cancelled, even if the same is detected at any stage of the contract and would lead to termination of the contract beside forfeiture of Security deposit and liabilities towards prosecution under appropriate law.

Note 2: Each Page of the bid document shall be signed and stamped by the bidder or Authorized Signatory.
