- Note : Physical submission of their documents is not required at the time of uploading of tender by bidders, However these documents should be submitted by bidder if asked by the institute subsequently for verification of documents
  - 1) Scan copy of Address Proof (Aadhar Card/Voter ID/Driving License/Passport or any other documents)
  - 2) Scan copy of deposit of Tender Fee & EMD.
  - 3) Scan copy of valid license duly issued by Central Pollution Control Board/State Pollution Control Board or any other authority and this license should be for dealing in the disposal of Non-Hazardous Items.
  - 4) Scan copy of GST registration certificate.
  - 5) Scan copy of PAN card.

### Kindly note that no physical submission of duly filled in BOQ is required and it is to be uploaded only on etendering website.

**4.** The items listed in Annexure 'A' can be inspected on any working day from 09:30 AM to 01:00 PM from the date of publication of tender, in Furniture Store (in front of Govind Bhawan) before last date of submission of bid and the bid can be submitted online at CPP Portal.

- 5. The highest bidder will be required to deposit 25% within 3 Days from date of issue of LOA his bid money in the form of demand draft or pay order or banker's cheque/NEFT/RTGS/Drawn in favour of the Registrar, IIT Roorkee. He shall also inform his e-mail address to the IE for conveying acceptance of the bid. Balance of the sale value with GST shall be paid by him in the form of demand draft or pay order or banker's cheque/NEFT/RTGS/Drawn in favour of the Registrar, IIT Roorkee within 7 days from date of issue of LOA.
- 6. In case bidders fail to deposit 25% of his quoted bid money within the prescribed time, his earnest money shall be stand forfeited. In case of Failure to deposit the balance of the sale value within the time prescribed in para 5 above, the earnest money and 25% of his quoted bid money shall be forfeited. The defaulting bidder shall be debarred from the participating in re auction.
- 7. Minimum Reserve/Salvage Price: The Institute has set a minimum reserve price for the lot of items to be disposed of through this tender. In case H-1 bidder has quoted less than the Minimum Reserved Price (MRP) fixed by the Institute, negotiation will be carried out with the H-1 Bidder. If the negotiation does not provide the desired result, then the reasonable price will be counter offered to the next highest responsive Bidder(s). The final decision regarding the award of the bid/disposal work will be made by the competent authority of IIT Roorkee.
- 8. The actual weight of unserviceable furniture items (wooden & steel scrap) may be more or less with respect to the weight mentioned in Annexure 'A'. The sale amount with GST shall be calculated on the basis of actual weight and shall be deposited by H-1 accordingly.
- **9.** Auctioned materials must be removed by the bidder within 20 working days from the date of issue of letter of Acceptance, either in the presence of successful bidder or an agent duly authorized by him in writing in this behalf. He will leave the storage place of the materials neat and clean.
- **10.** If the successful bidder fails to remove the materials within the 20 working days as specified above, the balance materials lying at the site will be confiscated by the office of the Executive Engineer (Civil)-I.
- **11.** If the successful bidder would acquire lien on the auctioned materials after the payment of full bid money and he will be responsible for any damage by way of pilferages, fire, or any natural calamity and no claim on this account shall be entertained.
- **12.** Security Amount will be released after 20 days from removal of the unserviceable furniture items by the H-1 Bidder.
- **13.** Any change in above schedule will be notified only on e-procurement website: (<u>http://eprocure.gov.in/eprocure/app</u>)
- 14. The materials must be removed in the presence of AEE (old Furniture) for site located at different places of IIT Roorkee.
- **15.** No claim for labour charges for collecting and stacking at a place will be entertained.
- 16. The highest bidder will have to pay all taxes if leviable on the materials after acceptance of bid.
- 17. The bidder shall have to abide by the timing of the IIT Roorkee and security rules of the Institute.
- **18.** Institute reserves the right to cancel any or all tenders without assigning any reason.
