Note: No exemption in tender fee and EMD shall be applicable for firms registered under MSE/NSIC/Udyog Adhaar. Therefore, all the bidders are required to submit the EMD and Tender fee as mentioned in Tender documents

3. Eligibility Criteria for submission of bid documents:

(a) Experience of having successfully completed similar work individually costing not less than as stated below during the last 7 years ending previous day of last date of submission of bids.

- (i) Three similar works, each of value not less than **40%** of the estimated cost,
OR
- (ii) Two similar works, each of value not less than **60%** of the estimated cost,
OR
- (iii) One similar works of value not less than **80%** of the estimated cost,

Completion certificate issued by Competent Authority will only be considered. Competent Authority means officer of not below the Rank of Executive Engineer/ Equivalent would be acceptable.

The value of executed works shall be brought to current costing level by enhancing the actual value of work at simple rate of 7% per annum, calculated from the date of completion to last date of receipt of applications for this tender. (Copy of work completion certificate to be uploaded as proof of eligibility criteria in Cover-1/ Technical bid).

(C) Similar works mean: - **Cleaning, collection & disposal of garbage & biodegradable and non-biodegradable waste from dustbins in segregated manner from PSUs/ Semi-Govt./ Govt. / Autonomous Institutions / Departments/ Offices.**

4. Turnover: The average financial annual turnover on similar works should be at least **50%** of estimated cost during the immediate last 3 consecutive Financial Year (2022-23, 2023-24, 2024-25) balance sheet duly audited by

Chartered Accountant. (Scanned copy of Certificate from CA with valid UDIN to be submitted with technical bid). The year in which no turnover is shown would also be considered for working out the average.

5. Institute reserves the right to cancel any or all tenders without assigning any reason.

- 5) Turnover Certificate from CA preferably with UDIN Number of last three consecutive financial years (2022-23, 2023-24, 2024-25) duly audited by a Chartered Accountant.
- 6) GST registration certificate.
- 7) PAN.
- 8) Copy of ESIC registration certificate
- 9) Copy of EPFO Registration certificate
- 10) Bank Solvency Certificate not less than 40% of the estimated cost of the work issued by a scheduled bank which is not more than 1-year-old from the last date of tender submission (including extension time).
- 11) Bank Mandate form as per Annexure-II.
- 12) Copy of proof of ownership/ hire of big size tractor & trolley/ tripper.

Note:

1. **If any information furnished by the bidder is found as false/fabricated then his/her bid will be rejected and treated as cancelled, even if the same is detected at any stage of the contract and would lead to termination of the contract beside forfeiture of EMD /Security deposit or both and liabilities towards prosecution under appropriate law.**
2. Each Page of the bid document shall be signed and stamped by the bidder or Authorized Signatory.
