# 2. Eligibility Criteria for submission of bid documents:

**a.** Intending bidder should not be a joint venture (Copy of relevant documents clearly establishing the status of bidder to be uploaded in Cover-1).

# For Civil Works (Prime Bidders)

- Experience of having successfully completed similar work individually costing not less than as stated below during the last
   7 years ending previous day of last date of submission of bids.
  - (i) Three similar works, each of value not less than 40% of the estimated cost, (Rs. 53.20 Lacs for each work) OR
  - (ii) Two similar works, each of value not less than 60% of the estimated cost, (Rs.79.80 Lacs for each work) OR
  - (iii) One similar works of value not less than 80% of the estimated cost, (Rs. 106.40 Lacs for each work)

Completion certificate issued by Competent Authority will only be considered. Competent Authority means officer of not below the Rank of Executive Engineer/ Equivalent would be acceptable.

- 3. **Turnover:** The Average Annual Turnover CA Certificate preferably with UDIN should be at least **50%** of estimated cost during the immediate last 3 consecutive Financial Years (2020-21, 2021-22, 2022-23) –balance sheet duly audited by Charted Accountant. (Scanned copy of Certificate from CA preferably with UDIN Number to be uploaded). The year in which no turnover is shown would also be considered for working out the average.
- 4. Institute reserves the right to cancel any or all tenders without assigning any reason.

- 6. No exemption in tender fee and EMD shall be applicable for firms registered under MSE/NSIC/Udyog Aadhaar. Therefore, all the bidders are required to submit the EMD and Tender fee as mentioned in Tender documents.
