2. Eligibility Criteria for submission of bid documents:

- a. Intending bidder should not be a joint venture (Copy of relevant documents clearly establishing the status of bidder to be uploaded in Cover-1).
- b. **Experience of having successfully completed similar work individually costing not less than as stated below during the last 7 years ending previous day of last date of submission of bids.**
- (i) Three similar works, each of value not less than 40% (i.e. Rs. 46,80,000.00) of the estimated cost,
OR
- (ii) Two similar works, each of value not less than 60% (i.e. Rs. 70,20,000.00) of the estimated cost,
OR
- (iii) One similar works of value not less than 80% (i.e. Rs. 93,60,000.00) of the estimated cost,

Completion certificate issued by Competent Authority will only be considered. Competent Authority means officer of not below the Rank of Executive Engineer/ Equivalent would be acceptable.


The value of executed works shall be brought to current costing level by enhancing the actual value of work at simple rate of 7% per annum, calculated from the date of completion to last date of receipt of applications for this tender. (Copy of work completion certificate to be uploaded as proof of eligibility criteria in Cover-1)

- c. **Similar works mean: - New Bituminous Road Construction with mechanical means /Resurfacing & Repair of Bituminous road by Hot Mix Plant.**

3. **Turnover:** The Average Annual Turnover CA Certificate preferably with UDIN should be at least **50%** of estimated cost during the immediate last 3 consecutive Financial Years (2020-21, 2021-22, 2022-23) –balance sheet duly audited by Chartered Accountant. (Scanned copy of Certificate from CA preferably with UDIN Number to be uploaded). The year in which no turnover is shown would also be considered for working out the average.
4. **Equipment Capacity:** Each Tenderer should further demonstrate: (a) Availability by owning and hire or lease the following key and essential equipment for this work.

5. **The contractor has to establish Batch type hot Mix Plant within 30 Km distance from Saharanpur Campus of IIT Roorkee.**
6. **Tenderer shall procure Bituminous materials (Bitumen Grade VG-30) for work from IOCL refinery only.**
7. Institute reserves the right to cancel any or all tenders without assigning any reason.
8. Institute will not be responsible for market fluctuation of rates, hence bidder is advised to consider the market fluctuation while quoting their rates. The quoted rate will be final for the entire contract period, no price escalation will be given by the Institute.

- 11) Bank Solvency certificate: Bidder should have to submit valid solvency certificate of the amount at least 40% of the estimated cost of the work issued by a scheduled bank which is not more than one year old from the last date of tender submission (including extension time). Certified copy of original solvency certificate to be uploaded in cover-1.
- 12) Proof of ownership or hire agreement for the requisite plant & machinery as mentioned in NIT.

Note 1: If any information furnished by the bidder is found as false/fabricated then his bid will be rejected and treated as cancelled, even if the same is detected at any stage of the contract and would lead to termination of the contract beside forfeiture of Security deposit and liabilities towards prosecution under appropriate law.

Note 2: Each Page of the bid document shall be signed and stamped by the bidder or Authorized Signatory.
